Due Dates: Jan. 1, Mar. 1, May 1, July 1, Sept. 1 and Nov. 1, 2012.

Participants who use supplemental funding, must choose Plan C.

Late payments incur a \$25 late fee. There will be a \$25 fee for returned checks.

MAKING A PAYMENT

Participants who discontinue their lessons are required to give a 3-week notice. A refund will be issued for any unused lessons.

Balances not cleared in 30 days result in the suspension of services and/or dismissal of participant.

Currently, there are two ways to make a payment:

1. With VISA or MASTERCARD.
 - a. Pay securely through the website (www.fieldstonefarmtrc.com) or
 - b. Complete a credit card payment slip available in the information kiosk in the mounting area and drop it in the student payment box.
2. With a check.
 - a. Either drop it into the student payment box in the mounting area or
