
From the Chairman of the Board of Trustees

Fieldstone Farm's high school for at-risk teens, has graduated 100% of all 15 eligible students since the school's inception in 2005.

In 2010, Fieldstone Farm's volunteer-driven campaign, "Support the Horse," raised \$29,100.

Fieldstone Farm offered more than **100 hours of training** to our community in 2010 including: Instructor Training and Certification, equine health seminars, disability overviews and a variety of other skill trainings related to our field.

Benefits of Therapeutic Riding

The equine programs at Fieldstone Farm are uniquely designed to meet the educational, behavioral, social and physical goals of people with disabilities.

Physical Disabilities:

The horse's unique, three-dimensional movement replicates the movement that the human body experiences while walking. Therefore, sitting on a horse helps to strengthen and stimulate core muscles, which often improves walking ability.

Cognitive Disabilities:

Programming complements the Ohio Academic Content Standards for language arts, math and science. The result is a creative, progressive, experiential learning opportunity, which directly relates to students' state-mandated academic goals.

Psychosocial Disorders:

Horses provide motivation and encouragement to riders. The relationship that develops between client and horse nurtures the development of skills such as responsibility, increased self-esteem, honesty and respect.

Our Honor to Serve

Since 2006, veterans of the armed forces from the Louis Stokes VA Medical Center have participated in riding and carriage driving programs at Fieldstone Farm. We have been honored to be able to offer our programming to this particular group of individuals. Since Fieldstone introduced this program, the VA has sent 24 veterans who have served our country in WWII, Korea, Vietnam and all of the Gulf region conflicts.

Volunteer Commitment

Fieldstone Farm volunteers demonstrate extraordinary commitment every day: to our students, our beloved therapy horses, the Gaitway school and to each other. Through selfless dedication and hard work, our volunteers contribute the workforce that runs our classes and improves our facility. In 2010, 700 volunteers donated 22,218 hours to our program by assisting our students, helping on committees, volunteering for special events and of course, working with our horses. The Independent Sector's current value of one hour of volunteer service is \$20.85, making our volunteers' efforts worth \$463,245 to the organization.

Therapy Horse Spotlight

Have you ever wondered what goes into becoming a Fieldstone Farm therapy horse? It's not as easy as you might think. In 2010, 137 phone calls were received from potential horse donors. Of that number, 32 horses were screened at their home barns. From those visits, 10 horses were brought to Fieldstone for the trial horse phase, a 6–8 week time period when staff and EMTs (Equine Management Team, a group of volunteers who meet weekly to help with various training aspects of the herd) work with the horse to ensure compatibility with our program and student population. From this group, 7 horses were accepted into the program. And you thought your job interview was tough! At year-end, Fieldstone Farm owned 36 carefully selected horses.

Programs at Fieldstone Farm

- **Academic Enrichment**—math, science, language arts and social skills focus that complement state-mandated curricula
- **Carriage Driving**—horse drawn carriage
- **Competition Opportunities**—two horse shows per year
- **EquiClub**—a 4-H club-styled horsemanship program
- **Equine Partnerships**—a social worker supported non-riding program
- **Gaitway High School**—for students needing a unique educational environment combined with mental health and social skills support
- **Hippotherapy**—physical or occupational therapy on horseback
- **Instructor Training Program**— education and skills training to become a certified therapeutic riding instructor
- **Specialty Programming**—programming specifically refined to meet the needs of those touched by cancer, students on the autism spectrum and our veterans of the armed forces
- **Summer Day Camp**—an equine adventure

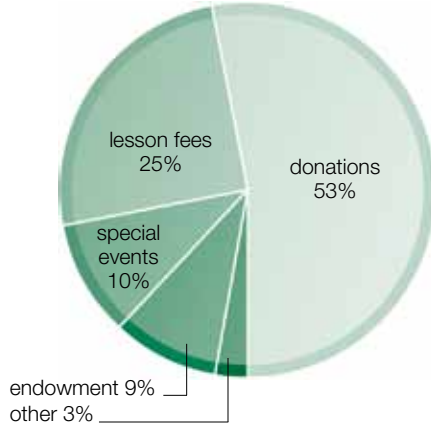

Total Operating Income \$1,471,824

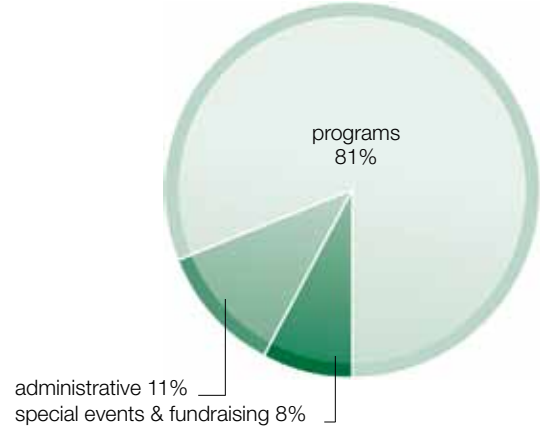
Total Operating Expenses \$1,511,434
