Dear Fieldstone Farm Students, Donors, Staff and Volunteers:

2008 was another amazing year at the farm! Progress was made in every area. Let me highlight a few of our most notable accomplishments:

Gaitway: The new Gaitway High School addition was completed on time for the beginning of the school year and the project came in slightly under budget. If you have not seen it, please stop by for a tour. Presently we are serving 18 students and approaching our goal of 24.

Students Served/Operations: We finished the year having served just shy of 800 participants, which is very close to our annual record and near our capacity. Significant progress was made in filling our volunteer needs and on a marketing strategy for sustaining these gains.

Instructor Excellence:

We launched a new effort to keep us at the forefront of the therapeutic riding industry to better resource, recruit, train and retain the staff directly interacting with our students. Please contact the development office if you would like to learn more about this initiative.

Financial: Despite the weakening economy in the 4th quarter, we finished within 3% of our bottom line objective and produced positive cash flow from operations. We are still raising capital replacement funds for the Gaitway High School addition; please contact our development staff if you have any leads for these types of donations.

Due to the economy and like most non-profit organizations, 2009 is proving to be a more challenging environment. As I write this in March, we are off to a good start but watching our financial and performance metrics very carefully.

Through a special partnership with horses, Fieldstone Farm Therapeutic Riding Center offers programs designed by professionals to foster personal growth and individual achievement for people with disabilities.

Brand New Building Kicks off a New Year for Gaitway High School

Gaitway High School, the only therapeutic riding high school in the country, began its fourth year in a brand new setting. The recently completed 2,720 square foot building expansion was greatly needed after the students and staff spent their first three years sharing the classrooms and other common public areas of Fieldstone Farm. The building, which was approved in 2007 by the Board of Trustees, was completed in time for the start of the 2008–2009 school year.

Gaitway High School was created to help students who need an alternative learning environment. Gaitway has created programming that not only provides vocational training but also helps

students fulfill their core course requirements for graduation, while also providing counseling and other mental health assistance all in one setting. Fieldstone Farm was a natural choice to host Gaitway High School because of the

ability to utilize the horse in the students' programming. In the '05–'06 school year, Gaitway High School was started with 8 students. Each year attendance has grown, and there are currently 18 students who attend for either full- or half- day sessions, not only from Geauga County, but also from the surrounding areas. The new building is able to accommodate 24 students along with the necessary teaching and support staff.

Because of the success of this program, Gaitway High School continues to garner national recognition. In 2008, Gaitway School received Honorable Mention for the Magna Awards. The Magna Awards are a national recognition program co-sponsored by American School Board Journal, the National School Boards Association, and Sodexo School Services. They honor school board best practices and innovative programs that advance student learning. Over the past three years every student eligible for graduation has graduated.



Kicking off their 4th year of academic excellence, Gaitway students and staff moved into a new state-of-the-art building in the fall of 2008.

Benefits of Therapeutic Riding

Fieldstone Farm Therapeutic Riding Center is a nonprofit organization that has been providing quality education and growth-oriented equine programs for people with disabilities since 1978. Programs offered are individually tailored to capitalize on the strengths of each rider. Fieldstone Farm is a Premier Accredited Center with NARHA, the national organization that sets standards for the therapeutic riding industry and certifies instructors.

Therapeutic equine programming involves horse-related activities uniquely designed for people with cognitive, physical, emotional and social disabilities. Students of all ages learn horseback riding skills and basic horse care while receiving many benefits such as: improved balance, mobility, muscle tone, coordination and posture, enhanced independence, and increased concentration and self-esteem. Horseback riding is a highly motivational and enriching therapeutic and educational tool for students to set aside their crutches, wheelchairs and disabilities as they settle into the saddle.

In 2008, more than 500 volunteers donated 19,300 hours of service to therapeutic riding at Fieldstone Farm in a multitude of ways. Using the Independent Sector's approved value of a volunteer hour (\$19.51), our volunteers contributed \$376,543 worth of service to our program.

- Fieldstone Farm currently has 13 different purebreds and 5 cross-breed horses.
- Fieldstone Farm horses consume 28,380 bales of hay in one year.
- Our largest horse, Baby Huey, a Percheron, weighs 1,700 pounds. Tinkerbell, our smallest, a 12 hand Welsh pony, weighs a mere 310 pounds.

Therapeutic Horses

All Fieldstone Farm horses are donated and carefully selected for their temperament and quality of movement. Horses go through a stringent trial and training period before being accepted into the program. At year-end 2008, Fieldstone Farm owned 34 horses.
