Benefits of Therapeutic Riding

Fieldstone Farm Therapeutic Riding Center is a nonprofit organization that has been providing quality education and growth-orientated equine programs for people with disabilities since 1978. Programs offered are individually tailored to challenge students to strive toward educational, physical, emotional and social goals. Fieldstone Farm is a Premier Accredited Center with NARHA, the national organization that certifies instructors and sets standards for centers providing equine-assisted activities.

Therapeutic equine programming involves horse related activities uniquely designed for people with cognitive, physical, emotional, and social disabilities.

Students of all ages learn horseback riding skills and basic horse care while receiving many benefits such as: improved balance, mobility, muscle tone, coordination and posture and increased concentration and self-esteem. Horseback riding is a highly motivational and enriching therapeutic and educational tool for students to set aside their crutches, wheelchairs and disabilities as they settle into the saddle.

Fieldstone Farm's Best Kept Secret

“You have a high school here at Fieldstone Farm?” We often hear this question. Yes, as a matter of fact, we do. In partnership with the Geauga County Educational Service Center (ESC), 25 high school students accomplish things they never thought possible. Fieldstone Farm is a non-traditional location for a public high school operating under the administration of the Geauga County ESC. Students attending Gaitway High School participate in a full academic schedule, vocational education and emotional wellness programs. Students are supported with a high teacher-to-student ratio, an environment of respect and caring and individualized learning opportunities. Students also have the opportunity to connect with and learn about horses. These factors result in dramatic increases in attendance and grade point average and significant decreases in incidents of discipline.

Volunteers

At Fieldstone Farm, it's not only about giving, but about receiving as well. Volunteers at Fieldstone Farm feel a sense of gratification by helping others in need; they feel a sense of accomplishment as they master new skills; and they feel a sense of pride as they assist others in achieving goals they never thought themselves capable of. Each day, our volunteers donate more than 75 hours totaling more than 21,000 hours last year. Without the dedication of 600 volunteers, our riders would not be able to mount up and "walk on!"

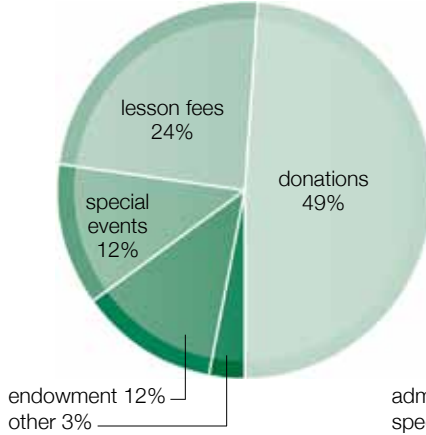

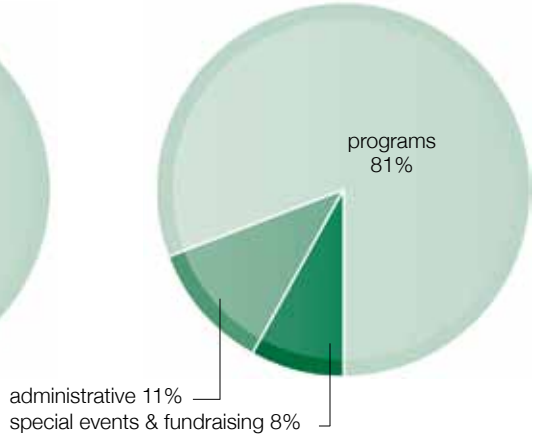
